4. Presentations

4.1 Delegation - Al Garland

Mr. Garland was unable to attend the meeting. The committee received the correspondence on affordable housing and food insecurities from Mr. Garland.

5. Items for Discussion and Reports

5.1 Notice of Motion for Choices Shelter Funding update

Chair, Mayor Brown provided an update to the committee on the notice of motion and the updated motion on Monday, October 4 requesting that Dufferin County provide the additional support for homeless men for the

fourth quarter of 2021 and first quarter of 2022 for Choices Shelter. The motion passed unanimously, and this should assist in Choices receiving their emergency funding for the men's shelter program.

Director Anne McGregor and Warden White from the County of Dufferin provided a presentation to Council on Monday and advising them of their programs, services and support.

Mayor Brown will provide the committee members with an update of the County Council proceeding after the Thanksgiving weekend.

5.2 University of Guelph Needs Assessment Update

Email received from Meaghan Wrathall, University of Guelph on Monday, October 4 provided the response results of the community survey; 14 service providers and 58 community survey responses were received. The committee will receive the draft data analysis prior to the final needs assessment report in November.

5.3 Sub-Committee Updates

5.3.1 Real Estate

The committee discussed the tiny house shelter complex concept. Mayor Brown informed the committee that he will be speaking to Ms. McGregor at the County regarding the concept. Member C. Sheehan stated security risks that should be factored into under this concept.

5.3.2 Funding & External Liaisons

Chair, Mayor Brown has reached out to CMHC for information on the forgivable low interest rate financing they provide for renovations and new construction for such shelter housing. The committee is not currently ready to submit the application until the needs assessment and location has been approved.

Fundraising has continued by the committee members. The farmers' market donation table has raised \$1,000, the Boston Pizza event raised \$1,100 and Carters Law firm donated to Choices Men's Shelter as well.
