5.1 Accessible Parking

James Jackson, Vice Chair spoke about accessible parking at the Orangeville Farmers Market and suggested the turning lane on Broadway be utilized as two temporary accessible parking spaces.

The Committee discussed the process of implementing accessible parking spaces throughout the Town, adding temporary accessible parking spaces, hiring consultants with lived experience to review new developments, adding accessible parking for the 2024 Blues and Jazz Festival to the work plan, and hand rails at Town Hall.

Note: Tony Dulisse, Manager, Transportation and Development will research temporary accessible parking spaces for the Orangeville Farmer's Market.

Lindsay Raftis, Secretary advised that certain projects will be required to be added to the work plan due to resources and budgetary impacts.
